Humanitarian relief

As I write this, in Honduras there are nearly 3000 confirmed cases of COVID-19. That may not seem like much compared to other countries; but, even under normal circumstances, the medical infrastructure here is inadequate. Already the few hospitals capable of treating patients are overwhelmed and many are turning away elderly patients.

In response to the presence of the virus, the government has implemented strict measures to increase social distancing. Currently, adults are allowed to leave their homes 1 day every 2 weeks according to the last digit of their national ID number, with exceptions given to essential personnel. This day is supposed to be used to do the banking and shopping necessary to care for your family. Masks are required to enter

I understand that similar measures in the States have caused strong debate. Here these measures have created much distress for families whose breadwinners are not able to work from home. Many day laborers have been without steady income or no income for 2 months now. The concern has been that malnutrition may cause more problems than the virus.

Fortunately, here in our city there has been a good deal of cooperation between the local government and many missions organizations. World Reach-Honduras has identified 65 families in our church plants around our city that we are trying to help. For \$23.38 we are able to purchase a good-sized bag of staples that can help a family with their food and hygiene for about 2 weeks. On two occasions we have been able to distribute this assistance.

It is an honor for us to be a part of God's strategy to do good during this time. Would you please prayerfully consider being a part of loving others in this way? Donations can be sent to World Reach via regular mail or the secure website indicating "Physical Relief - Honduras".











Reformatting our church leadership training curriculum

The pastoral training classes that we had planned for April were cancelled. And as we do not know how long the current situation will continue, we are working on alternatives. Together with several World Reach missionaries in Colombia and Peru we have been working on adapting classes for distance learning. Unfortunately, the students in our programs in Honduras and Peru live in places and circumstances where poor access to the internet does not allow us to provide lectures or other materials by that means.

We are working to develop a few classes whose lectures can



be saved to a micro sd card which can be watched on a cellphone. Although at this moment there is no way to deliver the sd cards and the printed study guide that will accompany it. (The majority of our students do not have a personal computer or a printer.) Mail services like we know them in the States do not function in these rural areas. These materials will be delivered by bus to be picked up at the local station. So we are working to have this ready when the bus routes open up again.

Family matters

We are grateful to you for your prayers on our behalf during our recovery from the automobile accident we had on March 1. Thankfully, there were no broken bones and no significant head traumas. We thank God that everyone involved has recovered well.

The accident was my fault. Our car was uninsured but the other driver's car was. So I must repay his insurance company. With many businesses closed due to the Corona virus this is still unresolved. I have communicated with the gentleman from the other car and he informed me that the insurance company considers his car totaled, however I have not received any confirmation from them.

My brother-in-law is currently lending us a car he was going to put into service as a taxi. At this moment taxis are not allowed to circulate, but we don't know how much longer he is not going to need his car. Would you please pray that God will provide for what is needed to fulfill my responsibility with the other driver and to purchase a "new" car for our family? At the time of writing, God has provided \$5,500 of the \$12,000 we believe that will be necessary.
