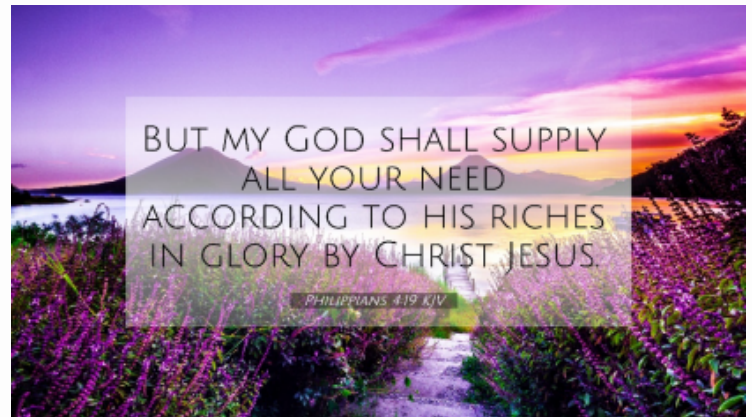

### How Is The Ministry Going?

With the collaboration of three fraternal ministries: Biblical Seminary, BE Ministries, and World Reach, we organized and carried out a special conference on "How to Lead Worship in the Local Church". We had more than 100 attendees, belonging to more than 10 churches and from 6 different Christian denominations. Dr. Rod Ellis of Woodburn Baptist Church of Bowling Green, KY was the instrument God used during this time. Dr. Ellis is a man



who is very profound in his biblical exposition, and at the same time very sensitive to the voice of God.



## Conference for Pastors' Wives

## Community Dental Clinic

She continues to care for the children of PRODIM Betel for free, and she provides dental treatments at very low prices for pastors and their families.



## Preaching and Teaching

Abner is always invited to preach and teach in different places. He preached to more than 200 young people at a local school, and he gave the invitation for the young people to acknowledge Christ as the Savior of their lives.



## Kids' Club

Alisson and Abner have attended every Friday to serve the public school children. During this last month, they had special activities like the celebration of Children's Day and Teacher's Day. Likewise, the children attended the kids' library to continue improving their reading comprehension and strengthening their fine motor skills. Ian Andrés has grown up in this ministry and is very involved with the Bible Club. He had the privilege of being the translator of the Bible lesson taught by sister Robin Lowe (we experienced so much emotion and gratitude that day). She encouraged Ian Andrés and gave him the confidence to translate the lesson. We enjoyed sister Robin's love and charisma, caring for our children and ministering to the school children.



## Bible School for Leaders

Abner traveled to the rural community of Tablazón to teach the "Introduction to Christian Doctrine" class. The students participated with questions, as well as in group work. Many of them came up to thank him for the class time, which, according to them, gave them a lot of new understanding.
